I am directed to convey the sanction of the President for payment of **Rs. 62,70,000/- (Rupees Sixty Two Lakh Seventy Thousand only)** to the Government of Uttar Pradesh as grants-in-aid for **Setting up Women Helpline in Lucknow, Uttar Pradesh under Universalisation of Women Helpline Scheme**. This amount includes Rs. 44,70,000 towards recurring grant **for the 1st half year of the financial year 2015-2016** and an amount of Rs. 18,00,000 towards non-recurring grant for **Setting up Women Helpline**.


2. The component wise overall ceiling for the recurring and non-recurring grant for **Setting up Women Helpline** are as under:

The expenditure is debitable to the 3601 (Major Head) ; 02-Grants for Central Plan Schemes (Sub Major Head), 356-Social Welfare- Child Welfare (Minor Head), 09- Women's Helpline (Sub-Head); 09.06.31 - Grants-in-aid-General (Object Head) in Demand No. 108 Ministry of Women & Child Development 2015-16 (Plan).

4. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid
