

In continuation of this Ministry's sanction of even number, dated 22nd March, 2019, I am directed to convey the approval of the Ministry of Women & Child Development, Government of India for allocation of additional quantities of **9150 (Nine Thousand One Hundred & Fifty) MTs of Wheat** to the State Government of **Tamil Nadu** (over and above foodgrains allocated *vide* this Ministry's letter of even number, dated 22nd March, 2019) under the **Wheat Based Nutrition Programme (WBNP)** and **National Food Security Act, 2013** at the subsidized price not exceeding **₹ 2/- per kg for Wheat** and **₹ 3/- per kg for Rice** to meet the Supplementary Nutrition under the Anganwadi Services [Umbrella Integrated Child Development Services (ICDS) Scheme] for the **2nd quarter of the year 2019-20**.

2. The allocation of foodgrains is subject to the condition that the State Government/UT Administration will ensure compliance of the extant provisions of the National Food Security Act, 2013 and Supplementary Nutrition (under ICDS) Rules 2017.
3. The terms & conditions mentioned in this Ministry's sanction of even number, dated 22nd March, 2019, will remain unchanged.
