The vehicle is available for inspection from 11.00 AM to 3.00 PM on all working days from **24.02.2016 to 04.03.2016.**
3. The interested Bidders may submit their bid application alongwith an Earnest Money Deposit of Rs.5,000/- by way of Demand Draft in favour of "Pay & Accounts Officer, Ministry of Women & Child Development, Shastri Bhawan, New Delhi.
4. The quotations received in time will be opened in Room No.313, 'A' Wing, Shastri Bhawan, New Delhi-110001. The Bidders or their representative (not more than one) may be present, if they so desire, at time of opening of quotations.
5. The auction will be governed by the following conditions:-
 - (i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.5,000/- latest within one week of opening of bids by way of Demand Draft in favour of "Pay & Accounts Officer, Ministry of Women & Child Development, Shastri Bhawan, New Delhi".
