**Subject : Release of Grants-in-aid to the UT for Nutrition Provision under the Scheme for Adolescent Girls (SAG) for existing 205 districts sanctioned in 2010-11 for the month of November 2017 to March 2018.**

Madam/Sir,

I am directed to convey the sanction of President to the payment of Rs.57000/- (Rupees fifty seven thousand only) to the following UT to the extent of amount indicated against each as grants-in-aid for the month of November 2017 to March 2018 towards GoI's share (100%) for Nutrition Provision under Scheme for Adolescent Girls:

2. The UTs will maintain separate records of expenditure incurred for implementation of Scheme for Adolescent Girls and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure on Nutrition Provision from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each UT Administration.

3. This grant-in-aid is towards the expenditure on nutrition component for the Scheme for Adolescent Girls. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

4. Scheme for Adolescent Girls is Centrally Sponsored Scheme in which the Centre and States/UTs both have contributions. The cost sharing ratio for the Scheme for Adolescent Girls has been revised from the financial year 2016-17 and the Union Territories will be funded 100% of the financial norms or the actual expenditure incurred whichever is less. The above funds are being released to UT on the basis of new cost sharing ratio and the amount of grant will have to be utilized for all the components under the Schemes as per the schematic norms.

5. The expenditure is debitable to the Major Head "2235" Social Security and Welfare: Sub-Head; 02- Social Welfare, 02.102- Child Welfare, 42-Integrated Child Development Services Scheme (ICDS), 42.05- Scheme for Adolescent Girls, 42.05.31-Grants-in-aid General in Demand No.99 Ministry of Women & Child Development 2017-18 (Plan).

6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D-Wing, Ground Floor, New Delhi.
