

The information on expenditure from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of each State Government/UT Administration.
3. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.
4. The expenditure is debatable to the 3601 (Major Head) 04-Grants for Centrally Sponsored Plan Schemes (Sub Major Head), 04.356-Social Welfare-Women's Welfare (Minor Head)-06- IGMSY 06.00.31 --Grants-in-aid --General in Demand No. 105 Ministry of Women & Child Development 2013-14 (Plan).


