Subject : Scheme of Assistance for Construction of Hostel Building for Working Women with Day Care Centre for Children- Grants-in-aid to **Kerala State Housing Board** at Muttom Village, Idukki District - Release of first installment.

Sir,

I am directed to say that the Government of India has sanctioned a non-recurring grant of Rs. 2,35,50,000/- (Rupees Two Crore Thirty Five Lakh Fifty Thousand only) as Central Government's share for expansion of existing working women hostel construction of additional block of a Working Women's Hostel for **74 Working Women** at Survey No. 17, Muttom Village, Idukki District, Kerala. The grant for construction of hostel building represents 75% of the total estimated cost of Rs. 3,14,00,000/- (Rupees Three Crore Fourteen Lakh only) as admitted for expansion of existing working women hostel subject to the condition that in case the actual expenditure on this project is less than the estimated cost, 75% of the difference between the estimated cost and the actual expenditure is required to have to be refunded by the organization to the Ministry.

2. I am, accordingly, to convey the sanction of the President to the payment to the **Kerala State Housing Board** of a sum of Rs. 1,17,75,000/- (Rupees One Crore Seventeen Lakh Seventy Five Thousand only) being the **first installment** of the grant for expansion of existing working women hostel which will be used as a hostel for working women. The construction of the Hostel is required to be completed in 24 months from the date of sanction of the first installment.

3. The grant shall be subject to further terms and conditions as laid down in the scheme. The organization will furnish audited accounts for utilization of the amount of this installment along with agency's share within six months of the receipt of this grant. However, in default the amount would be recovered as arrears of land revenue.

4. The accounts for the above grants will be subject to test check by the Comptroller & Auditor General or his/her representative and internal audit by the PAO of the Ministry whenever the institution or organization is called upon to do so.

The expenditure involved is debitable to Major Head "2235" -Social Security and Welfare, 02-Social Welfare, 103-Women's Welfare, 03-Assistance to Voluntary Organisations for Hostels for Working Women, 03.00.35-Grant-in-aid (Plan) under Demand No. 105, Ministry of Women and Child Development during 2013-2014.


7. This sanction issues under the financial powers delegated to the Ministries/ Departments of the Government of India and with the concurrence of the Integrated Finance Division of this Ministry vide their Dy. No. 1417/JS&FA/2013 dated 25.09.2013 and 9/DS (IFD) 13 dated 31.10.2013. The pattern of assistance of rules governing the grant-in-aid has received the approval of the Ministry of Finance.

8. Entry has been made in the GIA Register at Sl. No. 11.

9. The organization will submit Utilization Certificate of the Grant-in-aid by 16-08-2014.

10. It is requested that efforts may be made for awareness generation with regard to prevention and controlling HIV/AIDS amongst the beneficiaries.


