OFFICE ORDER

3. In case the officer fails to assume the charge of the post of Demonstration Officer Grade-II (ad hoc) within one month of this order, the orders of ad hoc promotion in respect of such officers shall stand cancelled automatically and they will not be considered for ad hoc promotion for one year from the date of cancellation of the order.

4. The ad hoc appointment shall not confer upon them any right to continue in the grade indefinitely or for regular appointment or to claim seniority in the grade of Demonstration Officer Grade-II.

5. The ad hoc appointment may be terminated at any point of time without giving any reason therefor.
