



OFFICE ORDER

The president is pleased to appoint **Dr. (Smt.) Sutapa S. Mukherjee**, regular Deputy Technical Adviser to the grade of **Joint Technical Adviser [General Central Services; Group 'A'; Gazetted; Non-Ministerial]** in the Food & Nutrition Board in the pay structure of Pay Band-3 (₹15,600-39,100/-) with Grade Pay of ₹ 7,600/- on ad hoc basis for a period upto 28th February 2015 or till the post is filled up on regular basis or until further orders, whichever is earlier.

2. **On her promotion to the grade of Joint Technical Adviser on ad hoc basis, Dr. (Smt.) Sutapa S. Mukherjee, presently Deputy Technical Adviser, Food & Nutrition Board (Eastern Region), Kolkata, is posted at the Food & Nutrition Board (Eastern Region), Kolkata against the one post of Joint Technical Adviser, Food & Nutrition Board (Hqrs.), New Delhi temporarily shifted to Food & Nutrition Board (Eastern Region), Kolkata.**
3. **The appointment as Joint Technical Adviser on ad hoc basis shall take effect from the date she assumes the charge of the post on promotion.**
4. **In case the officer fails to assume the charge of the post of Joint Technical Adviser (ad hoc) by the 31st March 2014, the orders of ad hoc promotion in respect of the officer shall stand cancelled automatically and she will not be considered for ad hoc promotion for one year from the date of cancellation of the order.**
5. The ad hoc appointment shall not confer upon her any right to continue in the grade indefinitely or for regular appointment or to claim seniority in the grade of Joint Technical Adviser.
6. The ad hoc appointment may be terminated at any point of time without giving any reason therefor.
