OFFICE MEMORANDUM

With reference to his representation, dated the 21st April 2014 requesting for retention at the Food & Nutrition Board (Hqrs.), New Delhi or posting in the Food & Nutrition Board (Northern Region), Shri Rakesh Kumar, Assistant Technical Adviser, Food & Nutrition Board (Hqrs.), New Delhi is hereby informed that his representation, dated the 4th April 2014 for his retention at the Food & Nutrition Board (Hqrs.), New Delhi or posting in the Food & Nutrition Board (Northern Region) on the same grounds has already been considered in this Ministry and his request could not be acceded to due to administrative exigencies.

2. Shri Rakesh Kumar, Assistant Technical Adviser was relieved of his duties at the Food & Nutrition Board (Hqrs.), New Delhi with effect from the afternoon of the 16th April 2014 with directions to report for duty at the Community Food & Nutrition Extension Unit (CFNEU), Food & Nutrition Board (Eastern Region), Kolkata immediately. It has been reported that even after expiry of the admissible joining time, Shri Rakesh Kumar has not assumed the charge of the post of Assistant Technical Adviser at CFNEU, Kolkata so far. He has been absenting himself unauthorisedly and he has not bothered about regularization of his absence. Shri Rakesh Kumar, Assistant Technical Adviser has failed to maintain devotion to duty and displayed a conduct unbecoming of a Government servant thereby violating Rules 3 (1) (ii) & (iii) of CCS (Conduct) Rules 1964.

3. Under the circumstances herein above, Shri Rakesh Kumar, Assistant Technical Adviser is hereby directed to explain as to why disciplinary case is not initiated against him under appropriate rules including termination of his services for violating Conduct Rules. The explanation must reach the undersigned by the 30th May 2014 failing which suitable action will be initiated ex-parte.


