RESOLUTION

In supersession of the earlier Resolution No.6(1)63.Tech.I dated 24.4.64 as amended subsequently vide notification No.22(3)/64-Tech.I dated 16.7.65 and No.22(1)/67-Tech.I dated 25.5.68 constituting the Food & Nutrition Board, the Government of India have decided to redefine the functions of the Food & Nutrition Board and reconstitute it as follows: -

FUNCTIONS OF THE BOARD

The Board will advise Government, coordinate and review activities in regard to:

- (I) diet and nutrition survey & Planning;
- (II) development, production & popularisation of nutritious foods & beverages;
- (III) measures required to combat the deficiency diseases;
- (IV) food & nutrition extension/education;
- (V) conservation and efficient utilisation as well as augmentation of food resources by way of food preservation and processing; and
- (VI) Such other matters as may be considered necessary, incidental or conducive to attainment of the aforementioned objectives.
