

The State Governments will maintain separate records of expenditure incurred for implementation of Scheme for Adolescent Girls and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure on Nutrition Provision from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central Assistance of each State Government.

3. This grant-in-aid is towards the expenditure on nutrition component for the Scheme for Adolescent Girls. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.

4. Scheme for Adolescent Girls is a Centrally Sponsored Scheme in which the Centre and States both have contributions. The above funds are being released to States on the basis of cost sharing ratio of 50:50 between the Centre and States. The sanction of funds is subject to the following conditions :

- i. The amount of grant will have to be utilized for all the components under the Scheme as per the schematic guidelines;
- ii. The States shall also be required to contribute adequate amount for implementation of the Scheme.



The State Governments will maintain separate records of expenditure incurred for implementation of Non-nutrition component under the Scheme for Adolescent Girls and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure for Non Nutrition component from 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of each State Government

4. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole. The grant-in-aid is subject to the condition that when the Scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will be shared between the Central and State Governments in proportion with their respective shares in the capital cost to assets.

The cost sharing ratio for the Scheme for Adolescent Girls from the financial year 2016-17 has been revised to 60:40 between the Centre and the State.
