The expenditure is debitable to the Major Head "3601' Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes (Sub Major Head); 358-Social Welfare-Child Welfare (Minor Head); 05 Integrated Child Development Services; 05.01 General Component; 5.01.31 Grant-in-aid (Plan) under Demand No.105 of the Ministry of Women and Child Development for the year 2013-14.


4. The amount of grant-in-aid is finally adjustable in the books of the Principal Accounts Officers, Ministry of Women & Child Development, New Delhi. Payment to the State Government would be arranged through the Reserve Bank of India, Nagpur. The Accountant General will send intimation regarding receipt of the grant-in-aid to the Principal Accounts Officer, Ministry of Women and Child Development, D-Wing, Shastri Bhavan, Ground Floor, New Delhi.

5. The State Government may ensure the following:

- a) *Send expenditure reports on a quarterly basis.*
- b) *Optimize the training capacity of the existing Training Centre.*
- c) *Submit the physical and financial progress report in the prescribed format on quarterly basis; and*
- d) *Match physical progress and financial release made.*
